Dr. Rick Tsai has been President & CEO of TSMC since July 2005, when he replaced company Chairman Dr. Morris Chang as CEO. TSMC is the world's largest dedicated semiconductor foundry.

David McCormick has been Under Secretary at the U.S. Department of Commerce since October As head of the Bureau of Industry & Security, he is responsible for overseeing the advancement of U.S. government policies at the intersection of national security, foreign policy, and trade interests, with particular attention to U.S. industry competitiveness.
